## SUBJECT: COVID-19

The situation with the Corona virus in the Republic of Croatia and throughout Europe is affecting the current operations of Adriatic d.d. as well as business activity forecasts for the near future.

All of the Company's hotels will be closed by March 27, 2020, and decisions on the seasonal opening of the hotels will be tied to the development of the market situation, or measures that will be taken by the National Headquarters for Civil Protection of the Republic of Croatia.
